

## Call for a Norfolk Coast youth delegate

### Role description

As part of the Norfolk Coast Area of Outstanding Natural Beauty 50<sup>th</sup> anniversary celebrations, and as an ongoing priority, the Norfolk Coast Partnership is seeking the input and engagement of young people in the conservation and enhancement of the area. We are seeking to recruit a youth delegate to attend the [Europarc 2018 conference](#) on our behalf on 18<sup>th</sup>-21<sup>st</sup> September 2018 - to network and come back with ideas on how to better involve young people in our work.

You will attend the conference and participate in the sessions, taking notes and making inputs as appropriate. Prior to the conference you will meet members of the staff team at the Norfolk Coast Partnership for a briefing. After the conference you will provide us with a video report on the conference, and attend a meeting to present your ideas.

### Person specification

We are looking for someone interested in the Norfolk Coast Area of Outstanding Natural Beauty and how young people relate to it.

You must be between 16 and 30 years of age.

You do not need specific skills or education but you must be able to produce a video report and participate unaided in the conference (e.g. to travel to and from conference by public transport, attend meetings, find your way around, speak to other delegates and network).

### Remuneration

This is a voluntary role and as such there will be no remuneration.

All reasonable expenses including travel by public transport, conference booking and meals for the duration of the conference will be covered by the Norfolk Coast Partnership.

### Application process

1. **A copy of your CV** (including name, address, date of birth and contact details)
2. **A completed Diversity Information Form** (see below)
3. **A short (three minutes maximum) video** made by yourself about the Norfolk Coast and what it means to you as a young person. To be provided in MP4 or similar format compatible with Windows Media Player, submitted via WeTransfer and clearly named as yours. This could cover the challenges, the past, present and/or future and should be presented by you in a style of your choice. By submitting it, you give permission for us to use its contents in future in our work. Any other people featured in it must give equivalent permission.
4. **Short answers to the following five questions** on the coast and the conference (all information is available on the [Norfolk Coast Partnership](#) and [Europarc](#)

[conference](#) websites). You may submit the answers in your covering email or as a separate attached Microsoft Word document:

A) Which year was the Norfolk Coast designated an Area of Outstanding Natural Beauty?

B) Under which Act of Parliament was it designated?

C) What is the statutory purpose of designation of AONBs under this Act?

D) At the conference, a special youth workshop on Wednesday 19<sup>th</sup> September will provide inspiration, guidance and information that will enable young people to plan how they can make a difference in their own local places. Which two experts will this be led by?

E) Which national park is leading on the project to develop a Youth Manifesto that will outline ways in which protected areas, environmental organisations and rural communities can meaningfully engage young people in their activities to safeguard the future stewardship of natural heritage and to retain young people living, learning and working in the rural environment and communities?

#### **After application**

The deadline for applications is 27/08/18. You will be notified if you have been successful on 30/08/18. All applicants will be contacted with feedback on their video and application, successful or not.

The successful applicant will need to attend a pre-conference briefing and meet the team at Fakenham on 03/09/18, and the conference on 18-21/09/18. They will then submit their report and video by 05/10/17, and present at a Norfolk Coast Partnership Forum/conference at a date to be confirmed.
